Campus Title 1 Parent and Family Engagement Policy

General Expectations:

- Dillingham Elementary School will jointly develop with parents and distribute to parents of participating children, a Parent Involvement Policy that the school and parents of participating children agree on.

Dillingham Elementary School will implement required school Parent and Family Engagement Policy components as followed:

1. Dillingham Elementary School will involve parents in the joint development and joint agreement of its Parent and Family Engagement Policy and its school wide plan, if applicable, in an organized, ongoing and timely way under section 1118 (b) of the ESEA.
2. Dillingham Elementary School will distribute to parents of students within their school and the local community the Parent and Family Engagement Policy.
